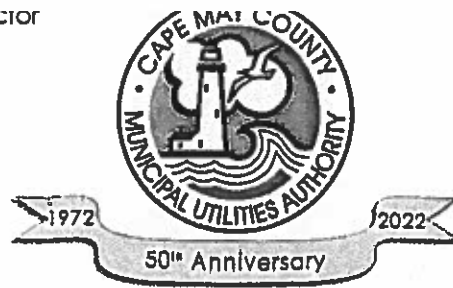



This contract consists of the replacement of various pieces of equipment and electrical upgrades to twenty-one (21) pump stations distributed amongst all four of the Authority's Wastewater Regions. Work consists of implementing a complete station bypass before demolishing and replacing key existing electrical and mechanical components including cabling, conduit, transfer switches, louvers, ductwork and grounding systems. All of the stations, except 3<sup>rd</sup> Street, will become equipped with a new exterior docking station that can be used to connect to an emergency portable generator, if necessary, in the future.

To date, the following twenty (20) stations are generally complete:

Madison (CM), Coral (CM), Claghorn (CM), 69<sup>th</sup> Street (SM/M), 81<sup>st</sup> Street (SM/M), Mayville (SM/M), Stone Harbor Manor (SM/M), Crest Haven (SM/M), 39<sup>th</sup> Street (SM/M), Spicer (WW/L), Neptune (WW/L), Oak (WW/L), Shawcrest (WW/L), Rio Grande (WW/L), 10<sup>th</sup> Avenue (WW/L), Lower Township EDS (WW/L), Rosemary Road (WW/L), 3<sup>rd</sup> Street (OC), 32<sup>nd</sup> Street (OC) and 20<sup>th</sup> Street (OC).

At the Cape May Court House (SM/M) Pump Station, an air flow test was conducted on May 3<sup>rd</sup>. The test was successful. However, while completing the physical work required to be done in the wake of the test, it was determined that one of the existing louvers will need to be replaced. Except for the various test reports that are to be submitted by the Contractor, this is the only actual work item that remains to be done in order to deem this project totally complete.

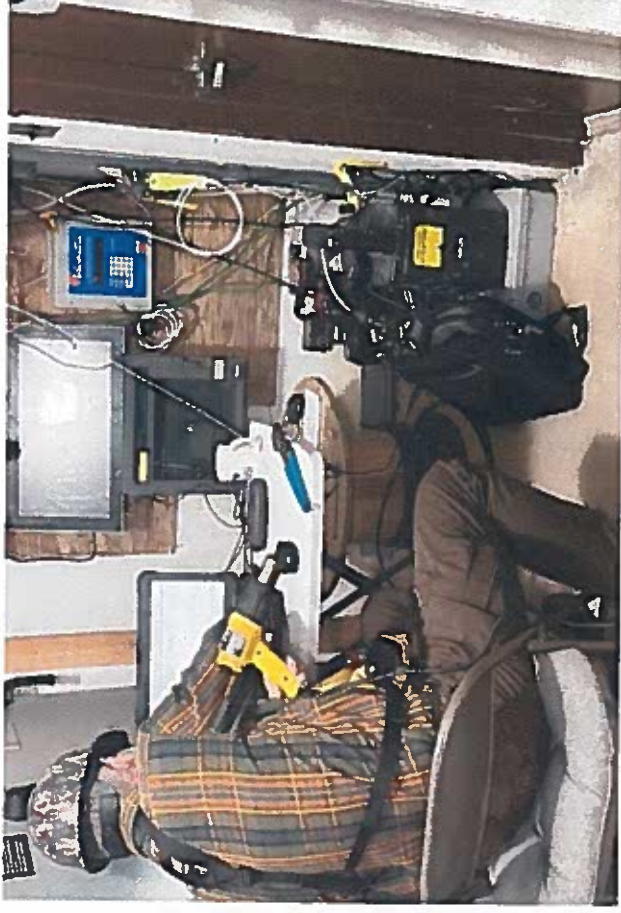

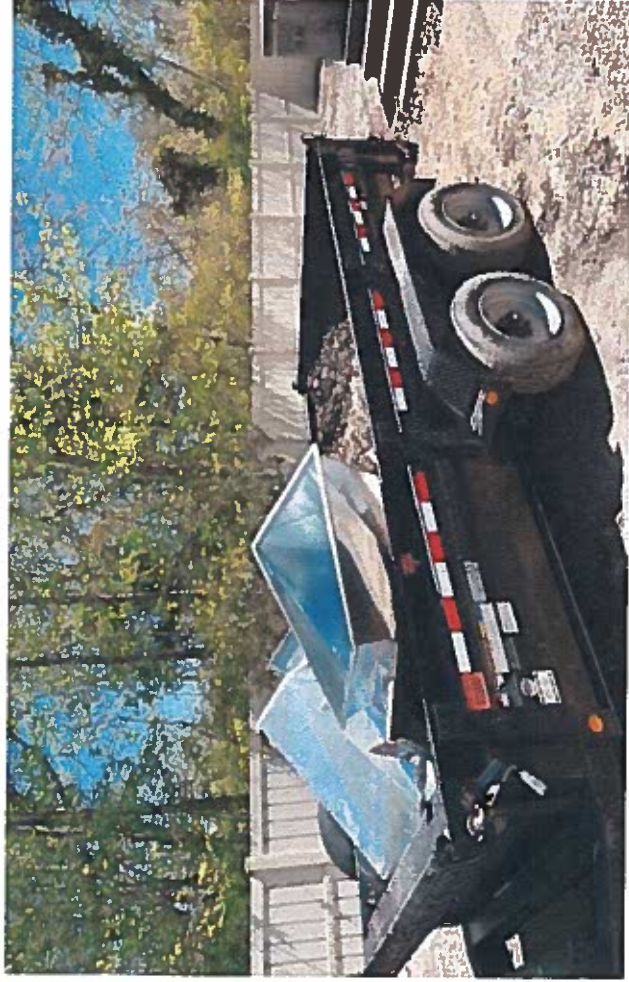

**WHEREAS**, pursuant to Resolution No. 112-21, the Cape May County Municipal Utilities Authority ("CMCMUA" and/or "Authority") entered into a Shared Services Agreement ("SSA") with the Township of Upper ("Township") for the preparation of a comprehensive wastewater study to determine the operational feasibility and potential capital costs associated with providing capacity by the CMCMUA for existing facilities or facilities to be constructed in excess of the Annual Charge, as defined in the Wastewater Service Agreement with Participants, for collecting, treating, and disposing of wastewater originating from or within the Township at the CMCMUA's Ocean City Regional Wastewater Treatment Facility ("OCWTF"); and,

**WHEREAS**, the OCWTF, a secondary treatment facility in the CMCMUA's Regional System with a permitted treatment capacity of 8.24 Million Gallons per Day, currently serves the City of Ocean City, a Participant in the Wastewater Service Agreement; and,

**WHEREAS**, the Township, a municipality currently not a Participant, as defined in the Wastewater Service Agreement, has expressed an interest in exploring the feasibility of providing sewer service to the Marmora Town Center District, the existing development along Roosevelt Boulevard, and future sewer service areas ("Base Condition"), as conveyed by the Township Engineer to the Authority and as cited in the Cape May County Wastewater Management Plan – Municipal Buildout Report for Township of Upper (Chapter 12) dated January 15, 2019, with the intent of wastewater originating from or within said areas would be treated and disposed of by the Authority at the OCWTF; and,

**WHEREAS**, pursuant to Article IV, Cost Responsibility, of the SSA, the Township shall be responsible for one hundred percent (100%) of the costs associated with the Base Condition; and,

**WHEREAS**, on January 14, 2022, pursuant to the New Jersey Local Unit Pay-to-Play Law (N.J.S.A. 19:44A-20.4 et seq.), the CMCMUA, as the SSA Lead Agency, advertised a Request for Proposals, RFP-06-22, entitled "Professional Engineering Services – Ocean City Region – Report: Impact of Increases Wastewater Flow from Upper Township to the Ocean City Wastewater Treatment Facility" ("RFP") to satisfy the conditions set forth in Section 202 of the Wastewater Service Agreement to study the operational feasibility and potential capital costs associated with providing capacity by the CMCMUA for existing facilities or facilities to be constructed in excess of the Annual Charge, as defined in the Wastewater Service Agreement, for collecting, treating, and disposing of wastewater originating from or within the Township at the CMCMUA's OCWTF; and,

**WHEREAS**, Section 4.3, Description of Scenarios, of the RFP detailed three (3) Scenarios, Scenario 1- Base Condition; Scenario 2 – Base Condition plus Option 1; and Scenario 3 – Base Condition plus Option 1 and Option 2, to which Proposers were to provide a total not-to-exceed cost for each Scenario; and,

**WHEREAS**, the Authority shall be responsible for one hundred percent (100%) of the difference in cost between the Base Condition and the cost associated with services performed under Option 1 or Option 1 plus Option 2; and,

**WHEREAS**, on February 17, 2022, the Authority received Proposals from three (3) qualified firms; and,
