To All Document Holders:

The following changes, additions and/or deletions are hereby made a part of the Contract Documents for the above referenced contract as fully and completely as if the same were set forth herein:

The following replaces Part D in SECTION IV, Page IV-1, 2.0 of the Technical Specifications.

Part D: Landfill Gas Powered Generator Motor Oil:

The proposed Petroleum Oil Product must be listed as an approved motor oil by Jenbacher Innio for use in a Type 3, Class C electrical generating engine with a sulfated ash content of less than 0.6%. Acceptable lubricating oil products listed by Jenbacher Innio for use in the electrical generating engines that meet these requirements are as follows;

The following replaces Part F in SECTION IV, Page IV-2, 2.0 of the Technical Specifications.

Part F: Ethylene Glycol:

The proposed Ethylene Glycol Product must be listed as an approved antifreeze by Jenbacher Innio for use in a Type 3, Class C electrical generating engine and have a 50/50 mixture ratio. Acceptable anti-freeze products listed by Jenbacher Innio for use in the electrical generating engines that meet these requirements are as follows;

- Artec - Havoline XLC 50/50
- Texaco Chevron Caltex - Delo XLC Antifreeze/Coolant-Premixed 50/50
